




## *Making History* Student checklist

Thank you for taking part in *Making History* and creating a digital history. Before you submit your work, please use this checklist to ensure that your project is ready to be uploaded.

- □ I have checked my work for any spelling errors or factual inaccuracies. I've consulted with my teacher and other students and incorporated their feedback into the final product.
- □ I have checked that all images, video or audio (including music tracks) created by other people and used in my project is able to be used on the web in a public domain. The items should be out of copyright, or be labelled by their creator as licensed for re-use. This might include Creative Commons licensed works.
- □ I have referenced and provided details for any of the materials used in my work and included this in the credits of my project.
- □ All participants in my project have signed a Participant Consent form, and I have explained to them that the project will be available online. I have shown the final video to the participant, they have confirmed the information provided in the project is accurate, and they agree to the video being published online.
- □ A parent or guardian has viewed the project and completed the parental consent section of the Student/Parental consent form (if I am under 18 years of age).
- □ I have read the Student consent form, and if I didn't understand any of the details of the form I have consulted with a teacher for assistance. I have signed the consent form.





# Making History Participant/interviewee agreement form

When interviewing anyone about their life, it is important to consider exactly what sort of information is being asked for and exactly what it will be used for. For this project, information should be for general knowledge, and consent must be given for its general use. Do not collect material that may be confidential and sensitive.

By completing the following form, participants agree to the following conditions of use and access:

**Use**: May be used by the researcher with unrestricted access for use as part of the current and future projects. Publication, public performance, broadcasting or telecasting of recorded materials and images will occur only with the prior written consent of the participant. Final edition of the audio or video recording to be used in a project must be approved by the participant. Final draft of any transcripts of recording must be approved by the participant.

**Access**: May be accessed by the general public under the access policyof the organisation where the recorded material is deposited.




### Details of works to be published by Museum Victoria


### INTELLECTUAL PROPERTY AND COPYRIGHT
